CONCEPT OF VILLAGE/WARD ADOPTION COMMITTEE: AN INGENIOUS MODEL FOR DEVELOPMENT

To usher in all-round development at grass root level, the role of the highest planning body in the District/State and the active participation of the grass root people need to be taken into account. This idea is incorporated in the concept of Village/Ward Adoption Committee undertaken by the Kohima District Planning and Development Board (DPDB), and this novel initiative has been featured in "New Beginning," a book on innovations for the Prime Minister's Award for Excellence, released by Prime Minister, Narendra Modi, on 21st April, 2017.

It was in the year 2010 that the Kohima DPDB brought out a concept known as Village Vision Cell with the theme 'Back to the root' which was re-christened as DPDB Village/Ward Adoption Committee in 2014. Initially, it was conceptualized with the name/term "Village Vision Cell" under the theme "Back to the Root," by involving people from all walks of life including retired Government servants/officers, politicians, social workers and other intellectuals.

A group of responsible people from a particular village forms a team called Village Vision Cell (VVC), who collectively coordinates with village leaders to improve the system of village level governance and to submit its vision and plans to the Kohima DPDB. The DPDB members are grouped into 6 DPDB Village/Ward Adoption Committees consisting of 9-10 officers and it has set up a Core Committee headed by Additional Deputy Commissioner HQ to evaluate the works of the 6 (six) committees annually.

Each Committee is assigned a village

or a ward, as the case maybe, to adopt and study the Village/Ward in detail, to ascertain the status of Government programmes, to locate lacunae and suggest measures to be taken. They also help to design and implement innovative programmes of the Committee in the Village/Ward, and finally, a detailed report on the Village/Ward is presented to the DPDB.

Initially, an amount of ₹ 50,000/was given from the Local Area Development Program Common Pool to each of the Committee, which was increased to ₹1,00,000/- in 2015. In 2016, it was further raised to ₹ 1,50,000/- in view of the positive impact of the programme on the adopted Villages/Wards and popular public demand. The amount so sanctioned is being used by the Committees for various expenses.

Till date, 20 (Twenty) villages in rural areas and 8 (Eight) wards in urban sectors have been covered under this Village/Ward Adoption Programme by the Kohima DPDB. Yearly competitions are also held to choose the Best Adoption Committee.

Objectives/Goals:

- To identify the needs of the villages, be it in economy, education, social, health and sanitation and assist them by using locally available resources.
- To create awareness of the activities of the DPDB.
- To develop cooperation and understanding and to inculcate team spirit amongst the member department for achieving synergy.
- To study the strength and weaknesses of the Village/Ward by gathering information on implementation of various Government schemes e.g. education, health, water supply and sanitation, power, forest conservation area,

transport and communication system etc.

To address and to propagate the best practices of a Village/Ward to other parts of the district.

Village/Ward Adoption - A unique opportunity:

- Bringing perceptible improvements in process/systems and building institutions.
- Making public delivery systems responsive, transparent and efficient, particularly by leveraging technology.
- The activities also spread awareness about various schemes available for development to both administrative departments and citizens.
- Optimal utilization of resources is made possible due to coordinated efforts through the Adoption Committees.
- Departments are able to get work done, which hitherto were not possible or difficult, through community participation such as removal of encroachments, widening of roads where private lands had to be touched, etc.
- Preparedness/performance in emergent situations, disasters like cyclones, earthquakes, floods, etc.
- Through the report of Ward Adoption Committee in 2014, a number of old and dangerously corroded electrical poles were identified and replaced, such as in North Block ward, by the Power Department. Also, removal of carelessly dumped distribution pipes at Porterlane in 2014 and implementation of compulsory septic tanks for houses were carried out by the KMC and Urban Development.

Problems and hurdles faced:

- Lack of authority to take larger decisions.
- Insufficiency of funds.
- Insufficient time.
- ➢ High expectation of the villagers/ward members: As with any Government developmental programme, there is usually a very high expectation of the adopted Village/Ward from the Adoption Committee, and not being able to meet these expectations is a major reason for disappointment. However, if sufficient funds are placed at the disposal of the Committees, perhaps it would help to a large extent.

Suggestions and ways forward:

- It would be beneficial if budget provisions can be kept aside for the Committees to work on by every department similar in line with that of IT policy of the State wherein, every department is required to set aside 3% of its planned budget for Information Technology
- All convergence programmes, particularly for the adopted Village/Ward, may be brought under the ambit of the Adoption Committee on trail basis for at least 3 years and thereafter, make it a permanent feature if it is successful.

Conclusion:

This model of "Bottoms Up" approach to planning and reporting has proved to be successful and beneficial, as is seen in the case of Kohima DPDB. As rightly said by Prime Minister, Narendra Modi, "Innovation is no longer a choice but has become an imperative," such models need to be emulated in other districts so as to fulfil the basic and priority needs of the local populace and also to bridge the vital gap between the Government and the grass root society.

AKSÜ BETWEEN AOS AND ANGAMIS DURING MOATSÜ 2017

Moatsü, the premier festival of the Aos was celebrated at Imkongmeren Sports Complex, Mokokchung on 2nd May 2017. This vear the celebration was in a mega scale where more than 1000 delegates from Angami Public Organization (APO) participated in the daylong celebration. The most significant event of the Moatsü 2017 was the good-will gesture shown between the two communities (Angamis and Aos). On behalf of the Angamis, President APO, Dr. Vilhusa Seleyi, presented a traditional Angami warrior shield and a spear to Ao Senden, a customary practice of the Angamis to show honour and respect for a big brother who is looked up to defend and guide the people.

The Aos reciprocated with the customary practice of peace making, treaty and reconciliation which is known as *Aksü*. *Aksü* is generally observed occasionally at three levels such as: inter-clan, inter-village and inter-tribe. The literal meaning of *Aksü* is "pig dead". Ak = pig, $s\ddot{u} =$ died, meaning the slaughtering of a pig and sharing between two groups in order to reconcile and strengthen the bonds between the two groups. Therefore, *Aksü* is an act of reconciliation observed between two parties as re-affirming their old peaceful relationship or renewal of good-will.

This is perhaps one of the best traditional methods of peace making processes, established from time immemorial. The celebration of Aksii signifies a time of joy and happiness. On this occasion, a pig is slaughtered in a ceremonial way and is divided in equal halves between two parties. Apart from head and innards, the pig is cut into two halves vertically through the center of the backbone leaving the tail to the receiving party.

One of the most significant outcomes of Aksü is the breaking down the barriers of hatred, suspicion and hostility between two groups. In other words, through Aksü, two groups come to appreciate the possibility of understanding by accepting one another. It also facilitates the two groups to re-affirm their comradeship and brotherhood. This is a time tested practice though no written records are maintained. Holding steadfast to the customary practice of reaffirming good-weill relationship, Aksü was observed between Aos and the Angamis during Moatsü 2017, where a pig was slaughtered in a ceremonial way and split vertically into two equal halves (apart from head and innards) through the center of the backbone. Following the traditional way, the half with the tail was offered to the guest (Angamis) as a mark of mutual respect and honour. Thus, the coming together of the two tribes is not an alliance to dominate others, but to foster the spirit of brotherhood, to reaffirm their kinship and renew their bond to epitomize the need to forgive and forget differences and to work together for the betterment of the society, thereby setting an example for posterity to live in peace and in harmony.

OFFICIAL ORDERS AND NOTIFICATIONS

TRANSPORT DEPARTMENT NOTIFIES

In compliance to the Judgment Order dated March, 29th 2017 passed by the Supreme Court of India in the W.P.(C) NO. 13029 of 1985 (under Article 32 of the constitution of India) the Transport Department, Government of Nagaland has notified thatvehicleswhether two wheeler, three wheeler, four wheeler or commercial vehicles that are not Bharat Stage IV (BS-IV) compliant shall not be sold in the State of Nagaland by any manufacturer or dealer with effect from 1st April, 2017.

All the vehicle registering authorities under the Motor Vehicles Act, 1988 are prohibited from registering such vehicles with effect from 1st April, 2017 that do not meet BS-IV emission standards, except on proof that such vehicles have already been sold on or before 31st March, 2017.

CHIEF MINISTER NAGALAND GRACES MOATSU AT MOKOKCHUNG



In her introductory speech, Dr. Temsula Ao mentioned that Nagaland State Commission for Women has been conducting Legal awareness programmes on Human trafficking in association with the National Commission for Women New Delhi since March and will continue till the end of May 2017. The first three programmes were held at college at Kiphire, Tuensang and Longleng followed by Meluri, Noklak, Tobu, Aboi and Longwa, Dimapur, Peren and Chiephobozou, and the programme held in Kohima was their 14th programme, she said.

She stated that only with a proper

networking of the Police, Child Rights agencies, Labour Department, Social Welfare, Mental Health and NGO's working in the filed can Human trafficking be prevented and contained. In this effort, the role of the Church could be significant because even the parents of victims need counseling. Dissemination about the establishment of One Stop Centre (OSC) and helpline 181 (for women) also needs to be extended to remote areas. For all these to happen, she said that the government has to be the enabling partner to all the allied departments. She urged the Naga man and women to dedicate themselves to eradicate such social evil that is continuously growing in the society.

Central Administrator of One Stop Centre (OSC), Vikereno mentioned about SAKHI, OSC scheme which was introduced by Ministry of Women and Child Development funded from the Nirbhaya Fund. These centres will be to provide integrated support and assistance under one roof to women affected by violence, both in private and public spaces. It was launched in Dimapur of June 2016 and in Kohima on December 2016.

The OSC will be integrated with

women helpline 181. It provides specialized service to women affected by violence.

'Human trafficking is a crime' said Legal consultant NSCW, Kriesino Kire. Knowledge is power she pointed, adding that law empowers citizen to fight for one's right. She further stated that human trafficking is the 3rd largest organised crime in the world. She also maintained that human trafficking does not only effect the girls which is usually the misconception in our society but now even boys are also trafficked for sexual exploitation.

Member Secretary, Nagaland State Legal Services Authority, Neinu delivering a short speech said that human trafficking is a serious problem faced by our society today. The programme was chaired Member NSCW, Asangla Chalong.

The HSLC and HSSLC Examinations 2017 commenced from 14^{th} February 2017 to 6^{th} March 2017 where a total of 37918 candidates appeared the examinations. In HSSLC Examination, there is an increase of 964 candidates. It took a period of 50 working days to prepare and declare the results. A.HSLC Examination 2017:

Out of 22446 candidates, a total of 15754 candidates qualified the examination with a qualified percentage of 70.19%. The last time the pass percentage crossed 70% or above was in the year 2009.

The girls have again done better with 8178 girls qualifying and 7576 boys qualifying the examination. In the Top 20 list, there are 45 candidates out of which only 13 are boys and the rest i.e. 32 are girls.

72 schools secured 100% qualified/pass percentage, up by 5 in 2016. Out of 72, 66 are private schools and 6 are government schools. This year too, 32 schools have zero/nil result out of which 30 are government schools and 2 private schools.

Since 2012, this year's performance is the best for government schools with a qualified percentage of 42.60.

In terms of district wise performance for government schools, Kohima district again topped the table with a percentage of 57% followed by Mokokchung district at 51%. Longleng district is at the bottom with 7%.

In respect of private schools, Kohima and Phek districts are at the top with a percentage of 86% followed by Mokokchung at 85%.

The number of candidates who secured 80% and above in aggregate is 944, up by 30 from 2016. Out of 944, 13 candidates are from government schools.

B. HSSLC Examination 2017:

This year again, the performance of girls are better than the boys. The girls pass percentage at the HSSLC Examination 2017 stand at 82.21% and the boys at 74.58%.

11(eleven) institutions under Arts stream, 4(four) institutions under Science stream and 4(four) institutions under Commerce stream secured 100% pass result.

1(one) private institution of commerce stream got zero/nil result.

SENSITIZATION PROGRAMME FOR IMPLEMENTATION OF PUBLIC FINANCIAL MANAGEMENT SYS-TEM (PFMS)

The two day sensitization programme for implementation of Public Financial Management System organized by Finance Department, Government of Nagaland under the aegis of PFMS, CGA, Ministry of Finance, Govt. of India was held from $15^{th}-16^{th}$ May, 2017 at the Directorate of Treasuries & Accounts, Kohima.

The resource person for the two day programme was Sr. Accounts Officer, K. Sridharan, who gave a brief power point presentation of PFMS and its benefits to the State Government.

PFMS initially started in 2009 as a Central Sector Scheme of Planning Commission. It is an integrated financial management system of Controller General of Accounts, Govt. of India and will be used for transaction preparation, bill processing, payment, receipt management, direct benefit transfer, fund flow management and financial reporting. All the ministries functioning Grant in Aid shall register all implementing agencies on PFMS to track fund flow under all plan schemes of Govt. of India and real time reporting of expenditure at all levels of programme implementation.

The decision of Government of India is to upscale the coverage of PFMS for Central Sector (CS) and Centrally Sponsored Scheme (CSS) to facilitate a robust system for ensuring 'just in time' releases in respect of CS and CSS and complete monitoring of utilization of funds under these two categories up to the end beneficiaries including information on end use of funds.

The biggest strength of PFMS is its integration with the Zone Braking System in the country. At present, PFMS interface is having interface in addition to the core banking system of all Public Sector Banks, Regional Rural Banks, Major Private Sector Bank, Reserve Bank of India, India Post and Cooperative Banks.

The programme was chaired by Principal Director, Treasuries & Accounts, K. Tiayanger Tzudir and the opening remark was given by OSD (General) Finance Department, V. Kezo. Sr. Budget Analyst, Finance Department, Ketoulhou Metha delivered the vote of thanks. Altogether 43 departments participated in the two day programme.

IPR CONDUCTS WORKSHOP ON COMPLEXITIES AND CONTRADIC-TIONS OF NEWS REPORTING

A workshop on the 'Complexities and contradictions of News reporting', organised by the Department of Information & Public Relations (IPR), Government of Nagaland was held on May 17 at the Capital Convention Centre, Kohima.

The resource persons for the workshop were Pradip Phanjoubam, Founder of Imphal Free Press, who spoke on Basics of News Reporting; Dr. Aküm Longchari, Editor, The Morung Express who spoke on Reflections on Media in Nagaland and Dzüvinuo Theünuo, Joint Director, DIPR, who spoke on the dynamics of Government public relations.

Editor, Imphal Free Press, Pradip Phanjoubam said democracy would remain incomplete without the existence of fourth estate. Resource person Phanjoubam said this during the one-day workshop held on complexities and contradictions of news reporting, organized by department of Information and Public Relations (DIPR) at capital convention, Kohima Wednesday.

Speaking on the basics of news reporting, Phanjoubam said journalism was about telling the story of events coherently and articulately, whereby one should have the basic communication skills. He said while writing a news story, it should be an inverted pyramid style stating that the headline and introduction of the story should capture the attention of the readers keeping in mind the five important Ws (who, where, when, what, why) and one H (how). Phanjoubam said a reporter must have the knowledge on the subject be it electioneering process, war or sports so that the key words were not missed. He also spoke on paid news, maintenance of neutrality etc.

Resource person, Joint Director Dzüvinuo Theünuo DIPR spoke on Dynamics of Government Public Relations. She said both the government press office and the media were fundamental to each other and share a common ground as their very existence were inter-dependent.

Speaking on ethics: code of conduct, Theünuo urged the journalists to be responsible, truthful, accurate and not to have conflicting interest but to work for public interest, be fair and be a steward of the public interest. She also explained how journalist and Government Public Relations Officers could work together to communicate information about the government to the citizens and respond to their concern.

She also dwelled on various other points like democracy and free press, empowering people, what press office does, link between the government and the people, journalists and government press officials, role of a press officer, government spokesperson, press conferences etc.

Resource person, editor of The Morung Express, Dr. Aküm Longchari spoke on "Reflections of media in Nagaland". Longchari said journalist or media houses should not let themselves be driven away by those at the helm of affairs, adding that neutrality should be maintained between the government and general public. He also suggested that routine coverage of events should not only contain the speeches of the chief guest but should also focus on the other aspects as well.

Longchari was optimistic on the suggestion of specialization and beat journalism in the state while also opining that the protection of the journalist's identity during critical reporting should be maintained by the editors and publishers. Stating that media has the power to bring about the social change in the society, he also informed to do grass-root reporting and also asked the journalist to know where he/she stands.

Asangla Imsong Deputy Director DIPR chaired the programed and Director DIPR Limawati Ao delivered the introductory note. Journalists from Kohima, Dimapur, Mokokchung, Kiphiri, Mon, PRO defense and the department officials from across the state had attended the one day workshop.

AHoDs AND HoDs MEETING

The meeting of the Administrative Heads of Departments (AHoDs) and Heads of Departments (HoDs) was held on 20th May 2017 at the Secretariat Conference Hall, Kohima under the chairmanship of Chief Secretary, Nagaland, Pankaj Kumar, IAS.

Highlighting about the secrecy of Aadhar data, the Chief Secretary said that government departments should be careful about protecting the secrecy of Aadhar data of any person, be it beneficiaries etc while uploading information on department websites. He said that departments cannot publish in any form the Aadhar number of any person. He also instructed that departments' websites should be made secure to protect from hackers.

The Chief Secretary also highlighted guidelines on the Do's & Dont's with regard to the usage of Aadhar data. With regard to 'Storage and data protection guidelines', an Agency using Aadhar must strictly follow all security guidelines specified by UIDAI. If an Agency is storing Aadhar number in database, data must be encrypted and stored. It should also be ensured that no Aadhar data is displayed or disclosed to external agencies or unauthorized persons. Regular audit must be conducted to ensure Aadhar number and linked data is protected, the guidelines stated.

Giving a presentation on "Land and Assets Management – encroachment and related issues", Deputy Commissioner, Kohima, Rajesh Soundararajan highlighted the various issues with regard to government land. He said that encroachments take place due to various reasons such as delay in lodging complaints or not lodging any complaint at all. In certain instances, government officials are in connivance with private individuals, coupled with lack of data base of assets and other documents such as survey maps etc. which pose a problem in protecting government land. He also said that government properties lack demarcation and protective fencing. He also highlighted about the eviction process followed, which normally takes up to two to three months.

T. Longri Ao, Managing Director, NSMDC gave a presentation on the products of the Nagaland State Mineral Development Corporation Ltd. that are produced through its three industrial units – the Decorative & Dimensional Stone Plant (DDSP) Chümukedima, the DDSP Wazeho and Mineral Industry Growth Centre (MIGC), Kiruphema. These units produces high quality slabs, artifacts, bricks, wall cladding, sandstone floor tiles, monoliths, pillars, hollow bricks, load bearing paver blocks and many others. Stating that the quality of products is in no way inferior to those brought from outside and that the rates are also very reasonable, T. Longri Ao suggested that government departments may encourage usage of these locally made products in all government initiated projects or constructions.

Earlier, the house took a Pledge in observance of Anti-Terrorism Day, which falls on May 21, but as the date falls on a Sunday which is a holiday for state government offices, the day was observed on May 20. The Chief Secretary led the house in taking the pledge to oppose all forms of terrorism and violence and to fight the forces of disruption threatening human lives and values.

PROFESSOR PARDESHI LAL ASSUMES AS NEW VC OF NU

Professor of Zoology, Nagaland University, Prof. Pardeshi Lal assumed office

as the New Vice Chancellor of Nagaland University (Central University) on Thursday 18th May, 2017.

It is the first time in the history of the university, that a Professor within the University was recruited to the post of the Vice Chancellor.

Prof. Lal was recruited as Professor of Zoology in the year 1997. Prior to his appointment as the Vice Chancellor he has served in different capacities from the Head of Department (HoD), Professor Incharge (PIC) in Lumami during Transit Headquarters in Kohima, Dean of School of Sciences, Controller of Examinations and Pro Vice Chancellor.

As per University Grants Commission (UGC) guidelines a person should have served as a professor for 10 years to be appointed as the Vice Chancellor. The tenure of office is for five years or till the age of 70 years, whichever is earlier. A person cannot be appointed as the Vice Chancellor of the same university for a second term.

TEAM LEADERSHIP & MOTIVATION TRAINING AT ATI

Madhav Dave, a sitting Minister of State for Environment, Forest and Climate. The house observed a two minutes silence in respect of the Late Anil Madhav Dave.





LEGISLATORS DELIBERATE ON GST

Chief Minister and Minister In charge for Finance, Dr. Shurhozelie Liezeiestu, moved the Nagaland Goods and Services Tax Bill, 2017 today, the 27^{th} May, 2017, in the 16^{th} session of the 12^{th} Legislative Assembly.

Participating in the discussion of the bill, Minister Roads and Bridges, Vikeho Swu apprised of the benefits of the GST regime. He pointed that the multiple layers of taxation will be eliminated, production at both national and international level will be boosted, the cost of production will be cut, goods and services will become cheaper besides the state gaining revenue. The GST regime will significantly improve the taxing system and boost the overall efficiency of tax in the state, he stated.

Also participating in the discussion, Parliamentary Secretary, Er. Levi Rengma, besides highlighting the benefits of the GST, called on the need for the state to gear up to be self-sufficient and independent in revenue. We should start assessing our self as a mature state especially in policies of taxes, he stated. The Parliamentary Secretary also appealed the concern department to make the system an all e-payment system.

Nagaland is a consumer state and when we have no system of revenue generation, the GST regime will create avenues for the same, said C. Apok Jamir, participating in the discussion on GST. He pointed that the system will promote and inculcate professionalism in the business community.

Minister of School Education and SCERT. Yitachu said traders and business people register in the name of STs and SCs to avoid taxes, thus depriving the state exchequer from revenue generation. He expressed hope that the GST system will do away with this illegal practice. The Act East Policy will enhance the trading activities and open up opportunities for the youth, which he said is a dream come true for the youths. He however pointed that the same will fail without the active participation of the stakeholders. Let us create amenities and open up avenues, he said, referring to the saturated avenues for more employment under the government.

Chairman DAN and Advisor of Finance, T.R. Zeliang participating in the discussion called for eliminating corruption and black money through 'technology checking'. He said that e-billing ensures 100% collected taxes comes to the state exchequer adding that only 30-40% of collected taxes presently comes to the state exchequer.

He further apprised that under the GST all Central Sales Taxes will come to the state exchequer unlike the earlier regime when all Central Sales Taxes goes to the manufacturing state. With the introduction of GST, the total tax payable will drastically come down to 28%, with the elimination of taxes such as toll tax, excise tax, or entry tax etc., from the present 32%, he said, thus benefitting the consumers to a great extent. He further pointed that with 4% cut in the payable taxes, the introduction of e-billing, and 100% collected taxes coming the state exchequer, the revenue increase in tax collection can be expected to increase by 400-500%.

He appealed the people especially

with small business establishment in rural areas not to panic as the GST regime will cover only those firms will annual sale return of Rs. 10 Lakhs and above. OFC lines has been provided to all district headquarters, including four sub divisions, which will solve the problem of internet connection in rural areas in its effort to introduce e-billing. With, all these in place, the slogan of 'one government, one tax' will become a reality, he said.

CHIEF MINISTER REMARKS ON GST

Chief Minister Dr. Shürhozelie Liezietsu in his concluding remarks to introduce Goods and Service Tax (GST) said that GST regime is going to be a milestone for making the tax administration in the state more effective and transparent and would have beneficial effect on the consumers and the economy as a whole.

Chief Minister said with the collection of tax in the state, it would see a rise in GST regime, however in the event of loss of revenue, state would be compensated for the shortfall in collection by the central government for the next five years for which the revenue act has already passed by the parliament.

Liezietsu said there are multiple subjects on which taxes are being levied and collected throughout the country yet the various provisions of the Constitution of India provide the sanction and clearly define the subjects on which the Centre and the States can levy and collect taxes.

In the present tax regime, he said if all the sale points happen to be within the State, there is some relief in the form of Value Added Tax (VAT) wherein one was allowed to take the credit for the tax already paid in the previous transaction. However, he said the tax structure does not provide any relief in the form of tax credit, if the goods are manufactured somewhere else and reaches Nagaland after passing through many intermediate taxpaying sellers, located in some other state or states.

CM informed that such a scenario will lead to avoidance of cascading of tax and bring down the cost of the product or service and finally benefit the end consumer and the system will also check tax evasion, since trade and industry will benefit by coming under the GST system through a "Self-Policing" mechanism. In the process, the tax base was likely to expand and lead to more revenue collection.

Further he said in the new tax regime, due to the "destination principle", where taxation was on supply and consumption and not on manufacturing, a State like Nagaland, which was pre-dominantly a consumer state will benefit and the introduction of the GST regime will open new era in the indirect taxation structure and administration in India.

SEMINAR FOR IMMUNIZATION AND MATERNAL AND CHILD HEALTH SERVICES AT KOHIMA

The inaugural programme of the two day workshop with religious leaders to improve demand for immunization and maternal and child health services in Nagaland was held on 30th May, 2017 at Hotel Vivor, Kohima with Minister for Health & Family Welfare, P. Longon as the chief guest. The workshop is being organised by State Health Society in collaboration with UNICEF.

Minister for Health & Family Welfare, P. Longon in his inaugural speech said that, the government of Nagaland is trying its best to work towards the welfare of the people of Nagaland and continuously making efforts to build our generation fit for future challenges, be it their competence to excel in their careers, the economic life, social or spiritual life.

He further pointed that the state coverage in immunization programme is low, the reasons being the low demand for immunization services in the state, information gap and fear of adverse events following immunization, parents and families do not know about vaccines, they do not feel the need for vaccination. He apprised that the government is making efforts to engage with communities in platforms such as village health and nutrition pays organized at villages by the health workers for community participations awareness.

Outlining the objectives of the workshop, Chief of Field Office, UNICEF, Assam, Dr. Tushar Rane said that UNICEF is supporting the respective state governments in the North Eastern states, and they have been doing so for the past 5 years. He spoke on the need to improve the infant mortality rate, which is 29 in the state.

General Secretary, NBCC, Rev. Dr. Zelhou Keyho mentioned that the church plays an important role not only in the faith matter of the constituents, but also in the social and health of its members.

Father Charles, representation from Catholic Association, Nagaland stated that the social mission of the catholic church is to enhance knowledge, skills and attitudes of the people in the village.

NSTC ORGANIZES SEMINAR ON RADICAL NITRIDING PROCESS

Seminar on Radical Nitriding process for improving the life of cutting tools for agriculture was organized by Nagaland Science and Technology Council (NSTC). The seminar was held at Nagaland Science and Technology Complex, Kohima on 30th May, 2017.

Resource person SG, Facilitation Center for Industrial Plasma Technologies (FCIPT), Institute of Plasma Research (IPR), Gandhinagar, Gujarat, Er. Dr. Alphonso Joseph, gave a powerpoint presentation on plasma nitriding system pointing that it is one of the best tools for farmer as it is more durable than other tools. She said that the plasma nitriding system is a heat-treating process which diffuses nitrogen into the surface of a metal to create a case-hardened surface.

These processes are most commonly used on low-carbon, low-alloy steels but on medium and high-carbon steels, titanium, aluminum and molybdenum. In plasma nitriding, the reactivity of the nitriding media is not due to the temperature but the ionized state of gas. In this technique intense electric fields are used to generate ionized molecules of the gas around the surface to be nitrided. Such highly active gas with ionized molecules is called plasma. The gas used for plasma nitriding is usually pure nitrogen, since no spontaneous decomposition is needed (as is the case of gas nitriding with ammonia). There are hot plasmas typified by plasma jets used for metal cutting, welding, cladding or spraving. There are also cold plasmas, usually generated inside vacuum chambers, at low pressure regimes.

Usually steels are beneficially treated with plasma nitriding. This process permits the close control of the nitrided microstructure, allowing nitriding with or without compound layer formation. Not only the performance of metal parts is enhanced, but working life spans also increase, and so do the strain limit and the fatigue strength of the metals being treated. For instance, mechanical properties of austenitic stainless steel like resistance to wear can be significantly augmented and the surface hardness of tool steels can be doubled. This tools like Satellite and Textile Company etc. are made through plasma nitriding system, the resource person said

WORLD ANTI TOBACCO DAY OBSERVED STATEWIDE

Kohima along with the rest of the world observed World No Tobacco Day on 31st May 2017 at Capital Convention Centre with the theme "Tobacco-AThreat to Development".

Parliamentary Secretary, Higher & Technical Education, Deo Nukhu speaking at the programme said that it was important to create awareness on tobacco among the people particularly more so as Nagaland is considered as the 2^{nd} highest tobacco consumption in India. He encouraged the younger generations to abstain from consuming tobacco as tobacco cause premature death world wide and 6 million death are related to tobacco and higher cancer case in Nagaland are attributed to tobacco consumption. However, he said this can be prevented if proper awareness is created.

Deputy Commissioner & Chairman DLCC, Rajesh Soundararajan IAS stated in this speech that tobacco related illness and is one of

the major preventable causes of deaths. He also mentioned that there is a rise among the younger generation to consume smoke from or smokeless form of tobacco which is turning out to be a habit. One of the main reason for this is due to peer pressure from friends.

Ambassador for tobacco smoke free Kohima. Sievituo Solo mentioned in his speech that he was influenced into smoking at an early age. But he made a decision that he should stop smoking tobacco and because of his abstinence he was able to take care of his health and be a fit young man which encouraged him to travel around the world in his bicycles for 6 years. As a brand Ambassador of tobacco smoke free Kohima he and his team will be collaborating with the Department of Health & Family Welfare to create more street art in and

around the districts to ensure awareness to the different groups in the society.

The program was chaired by Additional Director, H&FW, Tali Jamir. Toshimeren Walling of G.
