1. Only those candidates who have been found to be eligible by the Home Department after examination of the documents submitted, and other details provided by the applicant, may appear for the interviews for the post(s) applied by them.
2. The candidate may visit the site www.nagaland.gov.in and see the uploaded lists, or visit the Office of the Director of Sainik Welfare & Resettlement, Nagaland and Zila Sainik Welfare, Nagaland where the lists will be put upon the Notice Board or contact Police 'B' Branch Home Department during office hours, to find out if he/she is eligible for appearing for interview(s) for the post(s) applied by him.
3. In case a candidate is shown as being ineligible, and he is not satisfied with the reasons given for being considered ineligible, he may submit a representation giving the grounds on which he should be considered as eligible; to the Under Secretary, Police B Branch, Home Department (phone number 9436077127) either in person, or through email to sshnagaland@gmail.com/temsumozur@gmail.com not later than 7th of December 2021. The Home Department will examine the representation, and taking into account the facts presented and other relevant aspects, take a decision regarding the eligibility, and convey to the candidate, which shall be final.
4. All the candidates must furnish their original personnel/service documents before the Selection Board at the time of interview.
5. It may be noted that attendance in the interview doesn't mean automatic selection. The final selection and appointment subsequently of any eligible candidates a post will depend on the overall qualification of the candidate, his/her suitability, performance during interview; and other relevant factors as decided by the Selection Board, vis-à-vis other candidates, and as per the requirements of the Rajya Sainik Board/Directorate of SW&R, Nagaland.
