Age limits

1. Minimum -21 years & Maximum-30 years.

The upper age is relaxable by 5(five) years for ST, and 5 (five) years for Govt. employees who have rendered not less than 3 (three) years of continuous service.

2. As per P& AR No.AR-5/ASSO/98(Vol-1) dated 16/7/2021, there shall be relaxation of age for entry government service for a period of 1(one) year with effect from 22nd April 2020.

3. Reservation of post shall be as per the existing reservation policy of the Government of Nagaland.

4. Candidates should furnish self-attested Xerox copies of educational certificate, Indigenous certificate, Schedule Tribe Certificate, Backward certificate & Unemployment certificate along with the application.

5. The application with required certificates/documents should be submitted to Director General Home Guards, Civil Defence & SDRF Nagaland Kohima during office hours from the date of publication. Application will be summarily rejected if any of the above certificates/documents are incomplete/tampered or forged. Serving Government employees applying for the post should submit NOC issued by concern HOD.

6. Candidates shortlisted for the posts for viva-voce are required to produce original documents/certificates.

- (a) For Sl.no 1 & 2 Medical test, Physical test, written test and oral (for those passing Medical test, physical test & written test)
