Criteria/ Qualification for appointment of the Members of the Nagaland State Consumer Disputes Redressal Commission (State Commission) and District Consumer Disputes Redressal Commission (District Commission) are based under Rules No. 3 (2) , No. 4(2) , No. 6 (1-13) & No. 10 of The Consumer Protection (Qualification for appointment, method of recruitment, procedure of appointment, term of office, resignation and removal of the President and members of the State Commission and District Commission) Rules, 2021 is mentioned below:

A. Qualifications for appointment of Member, Nagaland State Consumer Disputes Redressal Commission:

(1) A person shall not be qualified for appointment as a Member, unless he is of not less than forty years of age and possesses :

(a) A bachelor's degree from a recognized university and is a person of ability, integrity and standing, and has special knowledge and professional experience of not less than twenty years in consumer affairs, law, public affairs, administration, economics, commerce, industry, finance, management, engineering, technology, public health or medicine.

(2) The Member of the State Commission shall hold office for a term of four years or up to the age of sixty-five years, whichever is earlier.

B. Qualifications for appointment of Member of District Commission:

(1) A person shall not be qualified for appointment as member unless he/she:-

(a) is of not less than thirty-five years of age;

(b) Possesses a bachelor's degree from a recognized University; and

(c) is a person of ability, integrity and standing, and having special knowledge and professional

experience of not less than fifteen years in consumer affairs, law, public affairs, administration, economics, commerce, industry, finance, management, engineering, technology, public health or medicine.

(d) The Member of the District Commission shall hold office for a term of four years or up to the age of sixty-five years, whichever is earlier.

C. Salaries, allowances and other terms and conditions of service of Members of State Commission & District Commission. - The State Government may, by notification, make rules to provide for salaries and allowances and other terms and conditions of service of the Members of the State Commission & District Commission.
