#### NBSE NOTIFIES HEADS OF INSTITUTIONS ON SINGLE USE PLASTICS

Nagaland Board of School Education (NBSE) has notified all the Heads of Registered Institutions that in pursuance of Government of Nagaland Notification No.UDD/7-GEN/07-PWM/2018(Pt-I) dated 11.03.2022 on imposing 'Ban on Single-Use Plastics in Nagaland,' all schools have been informed for proper dissemination of awareness on Plastic Waste Management with regard to ban of Single-Use Plastics, with a view to eradicate the menace of plastics and the serious environmental and ecological challenges posed by rampant use of it.

Single use plastics, otherwise known as disposable plastic items, are non-biodegradable and therefore contaminate the environment. The single use plastics include plastic bags, plastic water bottles, soda bottles, straws, plastic plates, plastic cups, plastic spoons, food packaging containers, plastic shopping bags etc. Single use plastics mostly end up in landfill sites which is a growing concern as it may take years to decompose and potentially leak pollutants into the soil and water. If plastic wastes are not properly disposed off, they get carried away by wind as litter or washed away by rain or travel via storm, drains into rivers and streams which pose a threat to the environment and human health.

In this regard, all institutions have been directed to inform and educate the students about the drastic impacts of disposal of wastes from plastics and plastic products which can lead to human health hazards, environmental pollution including natural environment beauty deterioration, entanglement and death of aquatic organisms, sewage system blockage etc, and to adopt measures to avoid its usage.

Further, as given in the academic calendar 2022, all Heads of Institutions should take measures to practice plastic free campus and advocate elimination of single use plastic items.

# SP CRIME INFORMS ON CLOSING CHECK GATES

In view of Government Notification No. CON-I/G/41/2011, dated 19<sup>th</sup> May 2022, regarding measures to tackle the illegal collection of money from vehicles at Check Gates and other locations in the State, PHQ has set up a dedicated '24x7 Control Room for Combating Illegal Collection of Money' manned by sufficient personnel and headed by a senior Police Officer to combat illegal collection of money from vehicles at Check Gates and other locations in the State.

Apart from the following 13 (thirteen) Inter-State Check Gates, all other Police Check Gates in any form, permanent/semi-permanent/temporary/mobile have been closed forthwith:

Besides the existing general helpline number of 112, the following dedicated mobile numbers and email ID have been placed in the Control Room for receiving any complaints/information regarding the illegal collection of money from vehicles at any Check Gate or any other location in the State or the presence of any unauthorized persons at the Check Gates, (i) 8798881978, (ii) 8798881979, and (iii) Email ID - PCRillegalcollection@gmail.com. The general public may also contact the Nagaland Police officers whose CUG (Closed User Group) mobile numbers are available in the 'Call Your Cop' Mobile App which can be downloaded from the 'Play Store,' The information can be shared with Nagaland Police via voice call, WhatsApp, text message, E-mail, and so on.

Nagaland Police has encouraged the general public to combat the menace jointly by providing specific information accompanied by photographic and video-graphic evidence regarding the illegal collection of money from vehicles at any Check Gate or any other location in the State or the presence of any unauthorized persons at the Check Gates. The confidentiality of all persons reporting such complaints shall be maintained if so desired.

# MEASURES TO COMBAT ALLEGED ILLEGAL COLLECTION OF MONEY FROM THE VEHICLES AT CHECK GATES AND OTHER LOCATIONS IN THE STATE

To curb the illegal collection of money from the vehicles on the roads, the State Government has issued several directives in the past. Reports, however, continue to be received alleging illegal collection of money from vehicles on roads and at various check gates by organizations, groups, government agencies, private individuals, etc. In light of the reports and to prevent and curb the illegal collection of money from vehicles by any entity or individual, the Governor of Nagaland is pleased to order the following for strict compliance by all concerned with immediate effect:

- 1. All Police Check Gates, except the existing inter-state check gates shall be closed forthwith.
- The check gates set up by other departments, including by Municipal and Town Councils, shall also be immediately closed throughout the State, except the inter-state check gates, which may function up till 31<sup>st</sup> May 2022, and beyond that date, shall function only after obtaining the specific approval of the Home Department.
- 3. If anywhere in the State, a check gate by any organization, group, or private individual, has been set up or functioning, for whatsoever reasons, that shall also be removed/closed forthwith.

- 4. In the event of additional inter or intra-district check gates required for unavoidable reasons by any department, including the Police Department, in any part of the State, the matter shall be referred through the AHoD/HoD concerned with justifications to the Home Department for consideration, and only after getting prior approval of the Government, the check gate will be set up by the department concerned.
- 5. Every department concerned after closing the check gate at any location in compliance with this order, shall dismantle and completely remove any temporary structure/building standing at the location and being used by it, to obviate the possibility of anyone else misusing the structure/space left behind for illegal collections purposes.
- 6. The Deputy Commissioner in every district shall constitute an 'Inspection Team' comprising the ADC (HQ), Additional SP/Addiitonal DCP, District Transport Officer, and the District Public Relations Officer (DPRO), which shall be responsible for ensuring that there is no check gate functional on any road in the district in violation of this order. The Team will move with a section strength force to be provided by the respective SP/DCP, and regularly conduct surprise inspections to check if any unauthorized check gate is functional, and in the event of any such gate being found, including by private groups, individuals, all the persons manning the gates shall be prosecuted under Sections 188 and 384 IPC. Disciplinary proceedings shall also be initiated by the department concerned against the government servants found involved, if any. Further, prompt steps shall be taken to dismantle and remove the unauthorized check gates put up by any department, local authority or organization.
- 7. The Inspection Team shall also conduct comprehensive inspections of the functioning of the duly permitted check gates to satisfy themselves that no illegal collection of money is taking place. In the event of any illegal activity found, the matter shall be immediately brought to the notice of the Deputy Commissioner concerned who shall forthwith submit a report to the Home Department through the Commissioner, Nagaland with his views. Further, the head of the office concerned in the district shall take penal action against the erring employees under the relevant sections of law besides initiation of disciplinary proceedings.
- 8. The person in charge of any check gate shall ensure that except the government employees detailed by the department, no other private individual is present at any point of time in and around the premises/ structure being used for check gate. The presence of any unauthorized person/group at or near the check gate shall be considered as sufficient proof of everyone colluding for the illegal collection of money and action as per law shall be taken against everyone.
- 9. The Inspection Team shall submit detailed reports of every inspection being made by it to the Deputy Commissioner, for perusal and for taking action as required. Further, the Deputy Commissioner through the DPRO, will ensure that the observations and findings of the Inspection Team, and the actions taken, if any, are given wide publicity.
- 10. The Home Department from time to time, will also be sending a team of officers from the Secretariat to inspect the check gates. The Department concerned may also regularly send their officers to inspect the check gates and submit reports to the Home Department.
- 11. The PHQ shall set up a Control Room to be manned on 24x7 basis, and share widely, the contact mobile number with WhatsApp facility, and an email ID, inviting people without requiring the person concerned to reveal his/her identity if he/she so desires, to share any report/information or make a

complaint regarding the illegal collection of money from the vehicles at any check gate or other location in the State, and the Control Room, which should be manned by sufficient personnel headed by a senior officer shall, besides passing on the information/complaint to the Inspection Team of the district, also give immediate further instructions for taking appropriate actions. A fortnightly report of the calls received and the action taken by the Control Room shall be made available to the Home Department for perusal.

- 12. In case of any information received of a vehicle that needs to be checked/inspected because of it being suspected of carrying illegal items, or if there is any contravention of any law/rule/regulation, or it has evaded paying any charges/fee/tax needed to be paid to the Government, or for any other sufficiently good reasons, the department officials concerned may immediately contact the Inspection Team of the district concerned and jointly carry out the necessary checks on the vehicle and take other action as necessary.
- 13. The Pulic Works Department shall put up prominent signages in local dialects/English and Hindi at every check gate/point declaring that no payment other than required by any law/rule/provision, if applicable, shall be made and that for such payments a proper receipt will be given. The contact number of the Control Room in PHQ shall be displayed prominently on the signages. The signages shall be erected and placed in such a way that they are prominently readable from a distance day and night.
- 14. The Deputy Commissioner shall obtain regular reports from the Inspection Team in the district, and on the 1<sup>st</sup> and 15<sup>th</sup> of every month submit a detailed report to the Home Department through Commissioner, Nagaland and shall certify the following:
- (a) Regular inspections are being carried out by the Inspection Team throughout the district to ensure complete compliance to this order
- (b) That no unauthorized check gate is functional in any part of the district.
- (c) At the permitted check gates, detailed inspection and thorough inquiries have been made, and there are no cases of illegal collection of money by anyone at such check gates.

# NLA ISSUES NOTIFICATION

Commissioner & Secretary, Nagaland Legislative Assembly (NLA), Dr. P.J. Antony has issued a notification in the light of the earlier decision of the NPF Legislature Party to join the United Democratic Alliance (UDA) and the recent merger of the 21 Members belonging to the Naga Peoples Front (NPF), led by T. R. Zeliang, Leader of the NPF Legislature Party, on 29.04.2022 with the Nationalist Democratic Progressive Party (NDPP), and the Order of the Speaker under Para 4(2) of the Tenth Schedule, read with the Members of the Nagaland Legislative Assembly (Disqualification on Ground of Defection) Rules, 2019 issued vide Bulletins-II No. 32 and 33 dated 29.04.2022, accepting the claim, T. R. Zeliang has ceased to be the Leader of the Opposition in the 13<sup>th</sup> Nagaland Legislative Assembly.

# (SCHOOL EDUCATION CLARIFIES)

Principal Director, School Education, Shanavas C, IAS has informed all the employees of the Department that the placement of fund for the current Financial year 2022-23 was issued by the Finance

Department on the 11<sup>th</sup> April 2022 and subsequently, the sub-allocation was prepared by the Directorate and submitted to the Finance Department on 14<sup>th</sup> April 2022 and authenticated, and the same was endorsed by the Directorate of Treasuries & Accounts on 20<sup>th</sup> April 2022 for circulation to the all the concerned Treasury Offices. However, with the introduction of the Personal Information Management System (PIMS)/ePay Bill system, the Directorate has been updating the information required by the P&AR Department in their interface vide their OM No.PAR/PIMS-2/2016 dated 27-05-2016.

With most of the employees being migrated to the PIMS, the Finance Department issued an OM vide No.FIN/BUD/12-3/e-Pay Bill/2021-22 dated 16<sup>th</sup> November 2021 for introduction of payment of salaries and wages via ePay Bill system effective from November 2021 but, due to glitches/requirement of documents/records, the system was relaxed till the remuneration of February 2022 to be drawn in March 2022, which had already been paid.

The Department would like to clarify that, the Directorate staff have been working overtime in coordination with the Finance Department, P&AR Department and the Directorate of Treasuries & Accounts so that salaries were released on time as the ePay Bill system was rolled in w.e.f. March 2022 but, due to some problems like pay items like SCRLA in the '93 RoP resolved by the P&AR on 7<sup>th</sup> May 2022, also, vide OM of the P&AR Department vide No.AR-5/ASSO/98 dated 6<sup>th</sup> June 2016, on ban of appointment on Adhoc/Contract, the records/ documents of such criteria could not be updated which have been compiled and forwarded to the Government and awaited for decision. Till such time, their salaries are withheld.

Also, the last 6 (six) SDEO establishments out of the 11 (eleven) newly created establishments, who had been bifurcated from their parent establishments, could not be updated in the PIMS for want of SGV code from the NSDL, Mumbai, which will be completed once the code is received and their salaries will be released accordingly. Also due to poor internet connectivity in areas like Kiphire, Tuensang and Mon, the problem of uploading details in the portal takes time hence, only 10 or 15 employees can be updated in a day. For the other regular employees, with the help of the P&AR Department, technical glitches are being cleared and for those already cleared, salary is being released on fast track mode.

In view of the above, the Department has reiterated that the Government has been trying to bring in transparency in disbursement of salaries and a system where funds are monitored properly. Since the system is in its initial stage, all the employees have been requested to bear with the delays as, once the problems are resolved, the system is put in place and information required are updated, all such delays will be curbed.

#### NBSE NOTIFIES HEADS OF REGISTERED INSTITUTIONS

The Nagaland Board of School Education (NBSE) has notified for information of all the Heads of Registered Institutions on the following:

- 1. The Midterm examination shall be conducted from 8<sup>th</sup> June to 18<sup>th</sup> June 2022. It should be conducted for the full 80 marks and not in a phased manner. This is to enable the schools to assess the learning outcomes of the student in a proper way.
- 2. Final examination will be conducted in two phases. The first phase will be conducted in September 2022. The second phase will be conducted in December 2022 as notified earlier vide NBE-8/Ad-

Misc(10)/2022-23/697 dated 4.4.2022.

 Schools should check the Academic Calendar and must read the Notifications/Circulars issued by the Board from time to time. Schools should also read the booklet on Management of Examinations and Assessment Guidelines and acquaint themselves with the rules/guidelines for the conduct of schoolbased examinations.

# POLICE ADVISORY ON PREVENTION OF ONLINE/MOBILE BASED FRAUDS

Superintendent of Police (Crime) and PRO, PHQ through a press release has stated that it has come to the notice of the Nagaland Police that fraudsters are impersonating the Political Executives/Senior Government Officials including the Police of Nagaland on WhatsApp and contacting officials or people known to them asking for assistance. The Modus Operandi is:

- Register on WhatsApp using black/fake SIM cards.
- > Use the photograph of the person impersonated as a WhatsApp profile picture.
- Get the name and phone number of potential victims from websites and other social media accounts (friends list) of the person impersonated.
- Share the link of Amazon Pay Gift Cards to the victims asking them to purchase the same and send the cards or the claim codes to the fraudster.
- > The fraudster claim they are out of town, in a conference/meeting, or otherwise engaged and that is why they need you to make the purchase for them.

Further, it stated that it has been observed that fraudsters are impersonating people on other social media platforms especially Facebook using the same modus operandi with the motive of asking for financial assistance and defrauding innocent victims. Nagaland Police has reiterated that one should not give/make any financial transaction to other people without ascertaining their identity.

# ONLINE REGISTRATION OF BIRTHS & DEATHS

To facilitate access to Birth & Death Certificates through online modes, the Department of Economics & Statistics, Nagaland has launched the Online registration of Births & Deaths on 19<sup>th</sup> April 2022. Currently, an applicant can register/apply for a Birth and Death event occurring within 21 days of the date of occurrence through this portal.

At present, the service is available only within the jurisdiction of Kohima Sadar for the Registrar of Births & Deaths, Directorate of Economics & Statistics, Nagaland and Registrar of District Economics & Statistics, Nagaland, and Registrar of District Economics & Statistics Office, Kohima. However, the service will be extended to other areas in a phased manner.

Applicants can access the online application through 'crsorgi.gov.in' and log in through the General Public Sign Up icon.

The certificates generated from the system have a unique registration number, QR Code, Bar Code, and embedded facsimile signature of the Registrar along with the imprinted Union, State, and Births & Deaths Logos.

These computer-generated certificates are to be recognized as legal documents along with the certificates issued manually by the Registrars of Births & Deaths.

#### AH&VS ISSUES PROTOCOL REGARDING AFRICAN SWINE FEVER

The Directorate of Animal Husbandry & Veterinary Services has informed the general public and piggery farmers that the occurrence of African Swine Fever (ASF) continues to be unabated in the State with positive cases reported from Tuli Block, Mokokchung district and Tizit Block, Mon district through RT-PCR from NERDDL, Guwahati.

The current trend of occurrence indicates that the disease is penetrating and spreading to various parts of the State, which suggests that the advisory issued is not fully complied with by all the stakeholders. At this stage, the 'Acute Form' of the disease is seen. The spreading of the cases in the State is a matter of concern to the Department, further, the abolishing of all Veterinary Check Posts and the porous borders have made the situation harder for carrying out containment measures.

Therefore, to contain the spread of the disease, the Department has appealed to the public, especially those farmers whose pigs have been affected to follow the following protocols:

- 1. Inform sudden death of pigs to the nearest Veterinary Institute.
- 2. Do not consume the dead pigs.
- List out the number of pigs that died along with photos, and approximate body weight, and after dully certified by the Village /Colony Authority the same must be submitted to the Chief Veterinary Officer for authentication.
- 4. Follow the deep burial method, at least 6 feet deep, followed by spreading of lime.
- 5. Do not throw the carcass in the river/canal stream/water bodies.
- 6. Sanitize the areas/sheds/troughs completely using the recommended solution.
- 7. Wash hands, feet, clothing, etc. properly with soap.
- 8. Seek the assistance of a Veterinarian for disinfecting the area.
- 9. Do not re-populate the pigs, without the Department's consultation.
- 10. Demarcate the areas into Infected Zone, Surveillance Zone & Free Zone with the help of Animal Husbandry & Veterinary Services Department for control and containment measures.

Further, the Department would like to inform all concerned that any queries on African Swine Fever may be clarified through Dr. Khriekuolie Linyü, Joint Director, ASF Core Committee Convenor (Mobile No. 6009753226), Directorate of Animal Husbandry & Veterinary Services, Kohima, Nagaland.

They were accompanied by Additional Secretary, Social Welfare, Bodeno S. Colo and Director, Social Welfare, Tosheli Zhimomi.

Life Connect Nagaland, a Christian organization under Sali Kez Ngully focuses on the fight against underlying causes of poverty and ensuring marginalized women a life of dignity and helping them live life to the fullest potential in the New Market Area, Kohima. Livelihood skills and training under 'Life Connect Craft' and 'The Happy Kitchen' provide an alternate source of livelihood to elevate marginalized women as persons of worth. 'Happy Flow' Project distributes free sanitary pads to enable women a stress-free period. Under the Children Impact programme, free tuition, life skills, and counseling are given to poor children and affected families.

Neithonuo T. Liegise, Founder and Chairperson of Good Samaritan Women Society, has been working for elderly care for the last 17 years by running Senior Citizens Home at Meriema and Ngwalwa. Liegise is presently the Program Manager of Elderline Nagaland '14567,' a National Helpline to attend and address the grievances of the senior citizens in the State.

Vilivi Sheqi is an entrepreneur, a life-skills teacher, and a freelancer based in Dimapur, working for the upliftment of women and children through entrepreneurship and skills-oriented programme and employment. She seeks to employ school drop-outs and victims of social and domestic violence. Sheqi also owns a baking and catering unit which employs young people with special needs.

Christy B. # UNION MINISTER OF STATE, RAJEEV CHANDRASEKHAR VISITS NAGALAND

Rajeev Chandrasekhar, Union Minster of State for Electronics & IT and Skill Development & Entrepreneurship embarked on a three day tour of Nagaland from 4<sup>th</sup> to 6<sup>th</sup> May 2022.

The Minister visited the District Civil Hospital in Mon, Nagaland, interacted with the doctors and other frontline workers who played a critical role in fighting the COVID pandemic in the district. He also noted that the Government of India has approved a Rs. 350 crore Medical College Project for boosting the healthcare facilities of the Border District with central assistance to the tune of around Rs. 292 crore. With an object to study the cultivation of Buckwheat and other Good Agricultural Practices (GAP) in Sikkim, a team of Agriculture Officials from the Department of Agriculture, Nagaland led by Dr. I. Amenla, Joint Director, ATMA visited Sikkim from 19th to 25<sup>th</sup> April 2022.

It was during the tenure of the then Governor, Nagaland, P. B. The construction of the RCC started in September 2016 but due to the pandemic, the progress was delayed and was extended till December 2022.

The structure is a three-storeyed building which will have a main theatre with a seating capacity of 2,000 people, a small theatre with 300 seating capacity, a 250 seat capacity conference hall and one hallway would be used as the Hall of Fame.

# NBOCWWB & DEPARTMENT OF FINANCE CONSULTATIVE MEETING WITH ENGINEERING DEPARTMENTS

The Nagaland Building & Other Construction Workers' Welfare Board (NBOCWWB) & Finance Department held a consultative meeting with engineering departments under the Government of Nagaland on 13<sup>th</sup> May 2022 at Conference Hall, New Secretariat, Kohima.

Chairman, NBOCWWB, Dr. Kekhrie Yhome said that the Board's primary function is to protect, provide and ensure social security for all those who are engaged in building and other construction activities. He said although the Parliament of India passed the Building and Other Construction Workers' (Regulation of Employment and Conditions of Service) Act, 1996 (Act No. 27 of 1996), which came into force on 1st March 1996, federal states were slow to implement, including Nagaland, and adoption of Nagaland Building and Other Construction Workers' (Regulation of Employment and Conditions of Service) Rules, 2010 began on 15<sup>th</sup> June 2011.

Yhome further stated that the NBOCWWB is a statutory and body corporate established

by an Act of Parliament. It is a health and welfare-oriented board with enforcement powers and Welfare Fund is incorporated into the Board, the fund is chiefly derived from the 1% Workers' Welfare Cess levied on the cost of construction. He added that the Building & Other Construction Workers' Welfare Cess (BOCWW Cess) is administered under the Building and Other Construction Workers' Welfare Cess Act, 1996.

Reiterating directives from the Supreme Court of India, Yhome said the Department of Finance, Nagaland issued standing notifications in 2012 to various concerned departments for compulsory cess collection and every drawal authority and sanction notification by the Department of Finance explicitly informs cess Many establishments, including deduction. Ministries under the Government of India, State Departments. and Government-run Public Sector Undertakings operating in our State, have not been dutifully remitting or reporting their cess payments to the Board. Likewise, delay in payment is another concern, which violates

procedures and for a salary-economy State like ours, the huge financial burden on public expenditure will immediately trigger an economic collapse, and the public will suffer from economic depression for many decades.

CEO, NBOCWWB, T. Chubayanger said that the Welfare Board is constituted to register the construction workers in the State and provide them social security by providing certain benefits. In order to provide these benefits, the Central Government created the Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Act, 1996. The purpose of this Act is to keep an eye on the working conditions of the workers. It acts as a social welfare scheme that works with the motive to provide benefits to the workers who are involved in the activities related to building and construction across the country. The CEO also said that they are trying to streamline payment of cess and renewal of registration through an online process that is available on their official website, which will help create a public domain through their online portal.

Commissioner & Secretary (Finance), V. Kezo, IRS commented that all concerned departments should comply with the Act given by the Supreme Court and that they should fully implement it. He said the Board will be applying a common yardstick for every department and will also try to work out a mechanism that will sensitize everyone about the Act.

YOLLOW KONYAK LAUNCHES REVISED NAGALAND STATE BIODIVERSITY STRATEGY ACTION PLAN

The Revised Nagaland State Biodiversity Strategy Action Plan (NSBSAP) was launched by Minister, Forests, Environment & Climate Change, Y. M. Yollow Konyak during the celebration of International Day for Biological Diversity (IDB) 2022 held at RCEMPA, Jotsoma on 20<sup>th</sup> May 2022. The programme was organised by the Nagaland State Biodiversity Board (NSSB) and Deutsche Gesellschaft fur Internationale Zusammenarbeit (GIZ) to commemorate the adoption of 22<sup>nd</sup> May as International Day for Biological Diversity under the theme 'Building a shared future for all life.'

Counsellor, Head of Environmental Affairs, German Embassy, New Delhi, Dr. Antje C. Berger addressing the gathering, stated that biodiversity remains the key answer to several sustainable development challenges. With two of the world's 36 Biodiversity Hotspots present in North Eastern Region, and Nagaland located in the Indo Burma Biodiversity Hotspot, she stated that the launch of the revised NBSAP is a step towards maintaining the unique landscape and management. With agriculture responsible for 70% of biodiversity loss, and with 52% of agriculture area affected by degradation caused by inappropriate production method, she stated that the 'Biodiversity and Ecosystem Services in Agrarian Landscapes (IKI-Biodev)' project aims to boost knowledge on increasing biodiversity and sustainable use of ecosystem and agriculture, and the project proved that agriculture practices can have positive effects in biodiversity and the ecosystem especially in Nagaland.

Dr. Berger stated that shifting cultivation has the potential to promote biodiversity and ecosystem improve services. agriculture production and resilience to climate change. generated The project awareness and strengthened the capacity of Jhum optimization and intensification measures while ensuring food and livelihood securities of farmers. The project will come to an end by November 2022 and a new project on Protection and Sustainable Management of Aquatic Resources in North Eastern Himalayan Region of India will be

undertaken in Assam, Manipur, Meghalaya and Nagaland.

Farhad Vania, GIZ India in his address shared that GIZ has been in Nagaland for over a decade, and has been working with Nagaland in biodiversity areas. He stated that biodiversity and climate change issues are becoming more complex, so have the search for solutions, and some of these now are of global importance. He said that it is not possible for one country to try and resolve by itself the problems, there is need for international cooperation and so recently, a Cabinet Consultation of Head of States was held where Prime Minister, Narendra Modi met Chancellor, Germany, Olaf Scholz on 2nd May 2022 and entered into Indo-German Green and Sustainable Development Partnership which has all the content for future development and gives direction especially in Sustainable Development Goals.

The Department of Environment Forests & Climate Change, Government of Nagaland, jointly with Centre for Environmental Studies,

North Eastern Hill University, Shillong had prepared the State Level Biodiversity Strategy and Action Plan (BSAP) of Nagaland in 2005. NSSB in collaboration with GIZ undertook the task to update and revise the BSAP of Nagaland according to the five strategic goals and the 20 Aichi Biodiversity Targets, the National Biodiversity Targets as well as the local realities and conservation scenario within the State of Nagaland. The Revised Nagaland BSAP was supported by the global project under the Indo-German Development Cooperation Project 'Biodiversity and Ecosystem Services in Agrarian Landscapes (IKI-Biodiv)' implemented by GIZ and commissioned by the German Federal Ministry for the Environment, Nature Conservation, Nuclear Safety and Consumer Protection.

The revised plan includes the identification of 12 new Biodiversity Targets for the State. The timeline for achieving these targets has been kept at five years with 2026 being the cut off year when it will be evaluated again.

#### POWER DEPARTMENT SIGNS PPA WITH FITZROY ENERY & MINERALS LTD.

A Power Purchase Agreement (PPA) was signed between the Power Department and Fitzroy Energy & Minerals Ltd. in the presence of Advisor, Power, H. Tovihoto Ayemi and officials from Power Department and Finance Department. Principal Secretary, Power, K. D. Vizo, Commissioner & Secretary, Finance Department, V. Kezo and Director, Fitzroy Energy & Minerals Ltd. Temjenmoa Jamir were the signatories. The PPA was signed for setting up of a 27 MW Thermal Power plant at Tuli in Mokokchung district.

Speaking on the occasion, Advisor Tovihoto said that the Department wants to encourage companies and entrepreneurs for investing in energy generation and stated that three more PPAs have been signed with different companies by the Department in solar, thermal and hydro energy generation and informed that a biomass energy generation plant is also in the pipeline. He further said that besides the generation of much needed power in the state, it will generate employment opportunities for Naga youths.

Temjenmoa Jamir, Director, Fitzroy Energy & Minerals Ltd. expressed his gratitude to the Advisor for his visionary leadership and foresight and thanked the Department officials for their support and dedicated efforts. He stated that results will be shown in the ground and hoped that it will be a significant addition to the growth of Nagaland.

#### STATUS OF NAGALAND INSTITUTE OF MEDICAL SCIENCE AND RESEARCH

The MoHFW approved the establishment of the Medical College with an intake capacity of 100 MBBS seats at District Hospital Kohima (NHAK) at the cost of Rs. 189 crore under the Centrally Sponsored Scheme for 'Establishment of new medical colleges by upgrading District/ Referral Hospitals' in 2014. As per the Guideline of the Scheme, one of the eligibility criterias was District Hospitals/Referral hospital with bed strength of 200 or more. Further, private hospitals are not eligible under the scheme.

The college will initially function from two plots - Administrative, Academic, Hostels, and staff quarters at Phriebagie, and the Teaching Hospital will be at Naga Hospital Kohima, which is permissible under the Regulations of National Medical Commission (NMC). However, in view of space constraints and instability of land at the Naga Hospital Kohima campus, it is difficult to develop the hospital to 500 bedded Teaching Hospital which must be in place by 3rd Inspection as per the Regulations of NMC. Therefore, a dedicated 500 bedded Teaching Hospital will be established at Phriebagie, and the construction of a 150 bedded hospital at Phriebagie through State Resources is nearing completion, while the Department has approached JICA for setting up a 400 bedded Teaching Hospital.

Though the Gol has approved the establishment of Medical College at Kohima in 2014, acquisition of land was completed only in February 2018. The Master Plan was approved in October 2018 and construction works commenced from 2019. Execution of works was severely affected during the COVID-19 Pandemic. Despite the initial delay, all works are in full swing and construction works are expected

to be completed within this year. So far, the Central Government has released its share of Rs. 170.10 crore, out of which, Rs. 77.73 crore have been utilized till date. The balance amount is available with the Government. The project was never grounded nor exhaustion of funds as published in some local dailies.

Considering the absence of iconic National Institutions in the State and limited financial and human resources, it is felt that the Medical College will be best run as a Central Institute, whereby the college may be even brought under the control of Nagaland University as practiced elsewhere. However, the Central Government has conveyed its inability.

The State Government has also created 60 various categories of posts required for obtaining Letter of Permission (LOP) from NMC. Advertisement for the post of Director was published nationally on 11<sup>th</sup> May 2022 and advertisement for the remaining posts will be issued shortly.

In connection with setting up of the Medical College at Mon, out of the total approved cost of Rs. 325 crore, the Central Government has released Rs. 232.23 crore as of date. The State Government has acquired 90 acres of land at Mon village which is about 3 Km away from the existing District Hospital Mon. The soil survey, contour survey works, preliminary works at the site including construction of road etc have been initiated, the bid documents and technical details for the remaining works have also been taken up. As per the timeline finalised with the experts and the Department, works are expected to start by the Third Quarter of this year.

#### FIRST OF ITS KIND, STATE-LEVEL CONSULTATIVE MEET

First of its kind, State Level Consultative meet with all Tribal Hohos on documentation of traditional attires, motifs, designs and ornaments was held at Capital Convention Centre, Kohima on 23<sup>rd</sup> May 2022.

Chief Minister, Neiphiu Rio said of late, there has been misrepresentation and incorrect usage of our traditional designs in fashion shows and on clothes being sold on e-commerce websites without any regard for the people who hold these traditional symbols in high regard. This misuse of traditional attires and symbols, known as 'Cultural Appropriation,' has to be guarded. He also said that cultural appropriation should be taken in all sincerity because the unregulated use of Naga cultural designs and symbols will lead to distortion and misrepresentation.

Rio clarified that it is not that others should not use our traditional attires nor should our communities and entrepreneurs be stopped from doing business in our traditional attires, but they have to be appropriately used. As such, the Chief Minister said that it is important that we should take steps to ensure that cultural heritage is protected under legal provisions such as Intellectual Property Rights and Geographical Indications. Only then, can we start controlling and regulating the use of our traditional attires, symbols, and ornaments. He hoped that all present at the programme would co-operate and contribute positively to this work which will ultimately benefit all the Nagas.

Advisor, IT&C, S&T & NRE, Mmhonlumo Kikon said the meeting was significant for the preservation of not only our culture and identity but the progress of the Naga people in the days to come. He said unless our rights are enshrined in the various systems that are available in the Intellectual Property Rights (IPR), we will be allowing people to take advantage of our heritage. The heart of the workshop, Kikon said, was to ensure that we not only sustain and keep our culture and heritage alive but also benefit in ways in which the new system will enable everyone to prosper, and for this to happen community engagement is the primary approach.

A brief introduction on the Committee was delivered by Commissioner & Secretary, Kekhrievor Kevichusa, IPos.

pending advertisement bills to clear them at the earliest.

The Chief Secretary reminded the AHoDs and HoDs to personally take care of court cases so as to void contempt of court. He informed that the first advertisement of NSSB will be out soon and instructed all concerned departments to submit their requisition posts at the earliest.

The Department of Industries & Commerce made a PowerPoint presentation on 'Ease of doing Business.' The Department stated that the Nagaland single window system is being developed for conducting business with government offices. The Department of IT&C gave an update on departmental website.

#### STATUS OF JAL JEEVAN MISSION IN NAGALAND

Jal Jeevan Mission under the Ministry of Jal Shakti, Department of Drinking Water & Sanitation aims to provide drinking water supply to the rural households through Functional Household Tap Connection (FHTC) by 2024. The Mission was announced by the Prime Minister of India, Narendra Modi on the 73<sup>rd</sup> Independence Day in 2019. The Mission is being implemented in Nagaland by the Public Health Engineering Department.

The JJM activities include the provision of drinking water @ 55 litres per capita per day, support activities that focus on IEC activities and capacity building for the rural communities to manage the completed schemes by themselves, and Water Quality Monitoring & Surveillance

- (WQMS) which focuses on water quality aspects. The Status as of 01/04/2022 is as follows:
- 1. Total no. of villages and habitations: 1499
- 2. Total no. of rural households: 3,77,286
- 3. FHTC provided: 1,56,984 (41.61%)
- Balance FHTC for coverage during FY 2022-23 (58.39%) (1,12,800 no. already approved during 2021-22 but spilled to 2021-22)
- 5. New schemes under planning for approval during 2022- 23 = ( 2,20,302-1, 12,800) = 1,07,502
- 6. Total FHTC target for FY 2022-23 (1,12,800+ 1,07,502): 2,20,302

The State has planned for saturation of all villages/habitations with FHTCs during FY 2022-23.

State, prices of essential commodities should come down and directed the Department of F&CS to monitor the situation.

Director, F&CS, V. Lovitoly Sema stated that the Department has been implementing various welfare schemes and programmes of the State and Central Governments across Nagaland. She stated that the Grievance Redressal Mechanism was in place and the Department was conducting Social Audits and maintaining Grievance Redressal System. She also added that one could check the details of NFSA Ration Card, Allocation, Supply Chain, Online Sales and Other services (such as 'Know Your Ration Entitlement') at https:// feast.nagaland.gov.in/ while details of foodgrains transaction under 'One Nation One Ration Card (ONORC)' i.e. Implementation of Ration Card portability 'One Nation One Ration Card" could be found at http://www.impds.nic.in/portal.

The Director also informed that Nagaland was the 1st State in the North East to launch the sale of 5 Kg FTL Cylinder through FPS with the assistance of IOCL and added that cylinder is available in 78 Fair Price Shops (FPSs) under Dimapur Sadar and the same will be rolled out in other districts in phase-wise manner. She further stated that the Department has completed 100% online allocation, 100% Supply Chain Management i.e. generation of indent to FCI for lifting of foodgrains till the distribution of foodgrains at Fair Price Shop Level using ePoS Devices, 95.06% Aadhaar seeding Status as on 1<sup>st</sup> March 2022 for the NFSA Ration Card.

Chief Secretary Alam said that due credit must be given to the Food & Civil Supplies Department for successfully seeding 95.06% of Aadhaar Status for the NFSA Ration Card holders. With the availability of a robust Grievance Redressal and Social Audit mechanisms, all complaints should be taken up on priority basis.

The Department of Land Records & Survey in their presentation stated that the Department is in the process of creating a Record of Rights from their level as well as digitize all existing maps and upload it online to enable the public to access their land records. The Department was advised to roll out an online single window system for land transactions for the benefit of the citizens.

#### STATE CIC CALLS ON CENTRAL CIC

On 27<sup>th</sup> May 2022, I. Meyionen Jamir, State Chief Information Commissioner made a courtesy call on Y. K. Sinha, Chief Information Commissioner, Central Information Commission at the CIC Office New Delhi, and discussed various issues relating to effective implementation of the RTI Act in the State.

The misuse of the Act by the RTI applicants for personal benefits, blackmailing of government departments and thereby, disrupting the normal functioning of office and measures to tackle such issues were discussed. The misuse of the Act by the PIOs and department officials by negotiating

It may be noted that Nagaland is one of the few states where suo moto disclosures by the public authorities are available on their official websites which was appreciated as a good practice. The State is also one of the nine states maintaining 100% responsiveness to the RTI applications.

I. Meyionen Jamir also attended the Board of Governors meeting of the National Federation of Information Commissions in India at CIC Bhavan, New Delhi.

#### SOCIAL WELFARE DEPARTMENT HIGHLIGHTS SCHEMES AS PART OF AKAM

In commemoration of 75 years of India's Independence, the schemes being implemented by the Department of Social Welfare such as 'Poshan Abhiyaan' and 'Pradhan Mantri Matru Vandana Yojana' have been specifically highlighted as part of Azadi Ka Amrit Mahotsav (AKAM).

Poshan Abhiyaan is a multi-ministerial convergence mission with the vision to ensure the attainment of a malnutrition-free India by 2022. It aims to ensure holistic development and adequate nutrition for pregnant women, lactating mothers, and children. The main objectives of the mission:

- (i) Prevent and reduce stunting in children (0-6 years)
- (ii) Prevent and reduce under nutrition in children (0-6 years)
- (iii) Prevent and reduce Anemia amongst young children ( 6-9 months)
- (iv) Reduce the prevalence of Anemia among women and adolescent girls (15-49 years)
- (v) Reduce Low Birth Weight (LBW)
   The pillars of the mission are Poshan
   Tracker, Convergence, Behavioural Change &
   Communication, IEC Advocacy, Incremental

Learning Approach, Innovations, Incentives, and Grievance Redressal.

Pradhan Mantri Matru Vandana Yojana (PMMVY) is implemented using the platform of Anganwadi Services Schemes of Umbrella ICDS under Social Welfare Department in the State. The objectives of PMMVY are to provide partial compensation for the wage loss in terms of cash incentives so that the woman can take adequate rest before and after the delivery of the first living child, encourage pregnant women and lactating mothers to seek improved health and nutrition behavior. Since the launch of the scheme in January 2017 in the State, it has benefitted 30748 pregnant women and lactating mothers. It aims to reach out to all deserving pregnant women and lactating mothers and regular identification and registration is done in and through the Anganwadi Centres and workers. Registration is also done at the CDPO Offices and District PMMVY cells attached to the District DPO Offices.

PMMVY is implemented in all the districts of the country where a cash incentive of Rs. 5000 is provided directly to the Bank/Post Office Account of pregnant women and lactating mothers (PW&LM) for the first living child of the family.

#### URBAN DEVELOPMENT DEPARTMENT ORGANISES ACTIVITIES AS PART OF AKAM

In commemoration of 75 years of progressive India, the Urban Development Department has undertaken various activities such as wall paintings, beautification of roundabouts (Chaurahas), and also organized competitions such as Essay writing, Photography, and

# 2,13,605 FARMERS RECEIVE INCOME SUPPORT UNDER PM-KISAN

The total beneficiaries registered as on May 2022 is 2,04,477. The e-KYC done so far against the total registered beneficiaries is 1,42,278 (70% of the total registered farmers). The 11<sup>th</sup> instalment will be released by the Ministry on 31<sup>st</sup> May 2022 by organising nationwide interaction of beneficiaries in commemoration with Azadi Ka Amrit Mahotsav celebration.

ODF Plus activities under Phase-II of the Swachh Bharat Mission (Grameen) have reinforced ODF behaviors and focus on providing interventions for the safe management of solid and liquid waste in villages, wherein, more emphasis will be made on access to a safe toilet, sanitary complexes, solid waste disposal systems, and grey water management in the rural areas in addition to retrofitting of rural toilets

and sanitary complexes to achieve ODF Plus status in rural villages.

Currently, there are 581 ODF Plus Aspiring, 621 ODF Plus Rising, and 230 ODF Plus Model Villages fulfilling the criteria for ODF Plus Rating. During the current FY 2022-23, the State has identified six districts and targets to fulfill those districts with ODF Plus components.

In addition, to strengthen the community and nudge the community into adopting safe and sustainable sanitation activities, various IEC & Capacity building activities have been planned i.e. PRA, production of IEC materials and wall paintings of IEC messages, cleanliness drive in villages to improve visual cleanliness and strengthen community participation, capacity building, and training on the role of WATSAN and Gram Panchayat in implementing grey water management and community participation at the village level, training for Swachhagrahis and WATSAN Committee Members, learning exchange/exposure visits to ODF Plus villages to see best practice, rewards, and recognition to Swachhata Champions, etc. With SBM(G) Phase-II implementation in progress, swachhagrahis in every village have been playing a role in creating awareness, also ensuring the village is benefitted with SBM(G) Phase-II components and moving towards the goal of achieving ODF Plus village to sustain ODF and safe sanitation practices.

Launching programme of Prime Minister Cares for Children was held at Conference Hall, Nagaland Civil Secretariat, Kohima on 30<sup>th</sup> May 2022.

Launching programme of Prime Minister Cares for Children Support Measures Scheme and Empowerment of COVID-19 affected children was held at Conference Hall, Nagaland Civil Secretariat, Kohima on 30<sup>th</sup> May 2022.

The scheme aims to support children who have lost both parents or legal guardian or adoptive parents or surviving parents to COVID-19 pandemic and the objective of the scheme is to ensure comprehensive care and protection of children in a sustainable manner and enable their well-being through health insurance, empower them through education and equip them for self-sufficient existence with financial support on reaching 23 years of age. The scheme of Prime Minister Cares for Children was announced on 29<sup>th</sup> May 2021.

As per the Ministry of Women & Child Development, financial support has been credited in the account of each identified child

such that the corpus for each child becomes Rs. 10 lakh at the time of 18 years of age. The child will receive a monthly stipend once they attain 18 years of age. It is also notified that by investing the corpus of Rs. 10 lakh, a child above 18 years will receive a stipend till they attain 23 years of age. An ex-gratia of Rs. 50,000 per deceased parent through SDRF-MHA directions. The PM Cares for Children scheme also includes to support for boarding and lodging and the financial support as prescribed for non-institutional care under the Central or State Scheme has been provided to the Children as per the eligibility under the Scheme. Under Child Protection Service (CPS) scheme, children staying with relatives receiving Rs. 2000 per month will now receive Rs. 4,000 per month with effect from 1<sup>st</sup> April 2022.

Under the Prime Minister Cares for Children scheme, entitlement in Financial Support, Support for Boarding and Lodging under the relevant Scheme, Assistance for School Education, Assistance for Higher Education and Entitle in Health Insurance under Ayushman Bharat Scheme (PMJAY) with health insurance cover of Rs. 5 lakh.

The Beneficiary Minor from Kohima district was hand over by Minister, Planning & Coordination, Land Revenue and Parliamentary Affairs, Neiba Kronu.

#### A BREAKTHROUGH FOR NAGALAND GOVERNMENT IN THE LITIGATION RELATING TO THE NAGALAND HOUSE AT SHAKESPEARE SARANI, KOLKATA

The Nagaland Government gained a breakthrough in the bitter and prolonged litigation relating to the Nagaland House at Shakespeare Sarani, Kolkata through the dedicated and sustained efforts of the counsel for the State of Nagaland led by Mr. K. N. Balgopal, Learned Advocate General, Nagaland who is assisted by Adv. Nitya Nambiar and Adv. Vitso Rio. Hopefully, the State Government will be able to get a favorable judgment against an entity that is trying to exploit some loopholes in the law to pay a paltry sum as rent. The history and intricacies of the case are explained in the following paragraphs.

On 24<sup>th</sup> December 1997, the State of Nagaland executed a lease deed in favor of Civil Engineers Enterprises Pvt. Ltd. (CEEPL), concerning premises No. 11 Shakespeare Sarani, Calcutta for 20 years. The said lease deed was to commence on 1<sup>st</sup> January 1998 and end on 31<sup>st</sup> December 2017. The total area

rented is 1,05,000 sq. ft. The premises are in the heart of Calcutta.

As per Clause 3 of the lease deed, the rent per annum was fixed at Rs. 5 lakh per month or Rs. 60 lakh per annum. Under Clause 2.1 of the said lease deed, the tenant was entitled to renew the lease deed by another 20 years subject to the enhancement of rent in terms of the West Bengal Premises Tenancy Act, 1997 (amended).

There was a further clause that after the expiry of the second term, the lessor i.e. the State of Nagaland shall renew the lease in favor of the lessee i.e. CEEPL for a further period subject to enhancement as per the market value as mentioned in the second schedule.

The State of Nagaland is the owner of the Nagaland House Commercial Complex located at Premises No. 11 Shakespeare Sarani, Calcutta. The complex includes many buildings including the 10-floor Nightingale Hospital.

The rent was fixed following the West

Bengal Premises Tenancy Act, 1997 and Rules. In case, a tenant comes under this Act, the rent will be nominal and not in accordance with the prevailing market rate. As per Clause 3 of the lease deed, the rent was fixed at a rate of Rs. 5 lakh per month on account of this Act. Not only was the rent to be fixed for the 1997 lease deed under the West Bengal Premises Tenancy Act, but in the renewal clause, it was mentioned that on renewal of the lease, the rent would continue to remain according to the rate prescribed under the West Bengal Premises Tenancy Act.

Incidentally, this Act does not cover premises owned by the central or the State Government and also any premises let out for non-residential purposes which carries more than Rs. 10,000 as monthly rent.

On the expiry of the lease by efflux of time on 31.12.2017, the tenant once again approached the government for renewal of the lease deed on the condition that the rent will be paid only as per the West Bengal Premises Tenancy Act, 1997. The State of Nagaland on the other side, issued notices to the tenant seeking payment of Rs. 2.2 crore per month as rent and refused to accept the fixation of rent in terms of West Bengal Premises Tenancy Act, 1997 on the ground that the said Act does not apply to the Nagaland State properties because under the aforesaid Act, State, and Central Government properties are exempted from its purview.

Further, some of the salient one-sided features of the lease were:

- 1. The tenant was entitled to sublet the premises to third parties on terms mentioned in the lease deed.
- 2. They were entitled to mortgage the property of Government of Nagaland.
- 3. They could take loans by using this property as collateral security.

4. 1500 sq. ft. free of cost for the entire lease period for the tenant.

In effect, the lease deed looked more like a sale deed because the lessee had supreme rights over the property and when he was put to notice that his lease is terminated by efflux of time for not paying enhanced rent, the lessee filed Civil Suit No. 26/2018 in the High Court of Calcutta seeking the relief of specific performance of the lease deed dated 24.12.1997 in which there was a renewal clause of payment of the rent in terms of West Bengal Premises Tenancy Act which the government refused to accept.

However, according to law, one cannot enforce an illegal agreement or an agreement against public policy or public interest. Meanwhile, the State of Nagaland filed Suit No. 242/2021 for possession and damages.

In the light of the above, the Civil Engineer Enterprises Pvt. Ltd. obtained a stay against the suit filed by Nagaland on the ground that if one suit has been filed and consequent to that, another suit has been filed by the opposite party, the first suit filed by the lessee shall take precedence over the second suit. This stay was for 2 months after which the stay automatically stood vacated. At the instance of the Chief Minister, about 5 MLAs/Advisors who were part of a committee attended the hearing in the High Court of Calcutta.

Since there was a possibility of the State of Nagaland being drawn into lengthy litigation, and since both the suits are between the same parties based on the same facts and law, it was decided to refer the cases from the High Court to Arbitration through there is no arbitration clause in the lease deed.

Accordingly, the High Court passed an order dated 06.05.2022 directing the case to be referred to arbitration and an Arbitrator was

appointed. Even after the order was passed, CEEPL attempted to get a stay of the suit of Nagaland and the same was opposed on the ground that the High Court has got no jurisdiction to decide this matter anymore as the matter has been referred to arbitration.

The State Government would move appropriate applications before the arbitrator for joint trial of both the cases on the ground confirmed by the High Court itself that the cases are between the same parties and the fact and law involved are the same. It may be noted the lessee did not allow the officials of the State to inspect the lease premises, nor did they furnish details of the sent deeds/taxes etc. Applications have been filed in the Court for direction to the lessee to disclose these facts to ascertain whether they have sold any part of the premises.

CEEPL also attempted to refer the case for mediation on the last hearing which was again rejected by the court when in open court, the court remarked that you are paying a paltry amount of Rs. 5 lakh per month in such a posh locality in Calcutta and therefore, you are not entitled to relief of mediation. The purpose of seeking mediation was only to put the case in cold storage.

By virtue of these orders, the State of Nagaland is in a more advantageous position.

for housing to socially and economically weaker sections in towns and villages. 18,430 beneficiaries in the rural areas and 31,241 beneficiaries in the urban areas have been assisted so far in the State.

Under the Pradhan Mantri Garib Kalyan Anna Yojana (PMGKAY) food security welfare, Rio said that it is a scheme announced by the Government of India on 26th March 2020, as part of an economic response to COVID-19 to ameliorate the hardship faced by the poor due to economic disruption caused by corona virus. Under the scheme, the CM said that the State is allocated additional food grains @ 5 kg/person/month free of cost to all the beneficiaries of AAY & PHH covered under TPDS as per the provision of NFSA. This allocation is over and above the normal monthly quota of NFSA. The Department has completed the scheme from Phase I to Phase V, covering about 14.03 lakh population in the State while the Phase VI is ongoing.

Under the Ayushman Bharat-Pradhan Mantri Jan Arogya Yojana (AB-PMJAY), Rio mentioned that as a flagship health insurance scheme by the Gol for the poor and vulnerable population launched on 23<sup>rd</sup> September 2018, it provides free health insurance coverage up to Rs. 5 lakh per family per year for hospitalized care. In Nagaland, the scheme has a target of 2.33 lakh households that were identified through SECC 2011, of which 1,03,718 families (44.5%) have been covered with at least one e-Card and more than 2.78 lakhs of individual e-Cards have been generated to eligible beneficiaries.

CM Rio said that the State is contemplating rolling out Chief Minister Health Insurance Scheme (CMHIS) from the 1st of October 2022 which aims to provide every citizen of Nagaland with hospitalization insurance cover of up to Rs. 5 lakh per annum, irrespective of the family's income. The scheme will provide cashless services for predefined packages covering secondary and tertiary care procedures at empanelled government or private hospitals, both within and outside the State.

The State Government has also designed a Micro-Finance Scheme which will provide subsidized loans to the farmers and entrepreneurs in the State, which will be introduced in the coming month.

While interacting with the Chief Minister, the beneficiaries from the districts thanked the government for introducing different welfare schemes to uplift the economic status of the poor and downtrodden section of the society. The beneficiaries also expressed satisfaction and contentment over the implementation of different welfare schemes by the government departments.

In conclusion, Rio said that the State Government and the Central Government will continue to build the capacities of our people, and provide the environment with sufficient opportunities for the innate strengths of our people to grow equally with the national economy. With the active participation of the departments, legislators, and the village councils, there will be a change in the present scenario and the future of the State too.

This event is also one of the largest ever single-event nationwide interactions spanning all the districts where the Prime Minister interacted with beneficiaries about the impact that the wideranging schemes/programmes covering housing, availability of potable water, food, health and nutrition, livelihood, and financial inclusion, etc. have had on their lives.

## AN OVERVIEW OF THE RESULTS OF HSLC & HSSLC EXAMINATIONS 2022

The HSLC Examination 2022 commenced from 9th March 2022 and concluded on 22nd March 2022 and the HSSLC Examination 2022 commenced from 8th March 2022 and concluded on 31st March 2022.

In HSLC, a total of 28938 candidates were enrolled and in the HSSLC, a total of 17121 were enrolled for the examination. 1392 candidates were enrolled for HSLC Compartmental Examination 2022 and 901 qualified the examination with a pass percentage of 64.73%.

#### A. HSLC Examination 2022:

Out of 28938 candidates, a total of 18721 candidates qualified the examination with a qualified percentage of 64.69%.

#### The overall pass percentage for the last 5(five) years are as follows:

10021 girls and 8700 boys qualified the examination. In the Top 20 list, there are 62 candidates out of which 18 are boys and the rest 44 are girls. 90 schools secured 100% qualified/pass percentage. Out of 90, 78 are private schools and 12 are government schools. This year, 34 schools have zero/nil result out of which 33 are government schools and 1 private school.

In terms of district wise performance for government schools, Kohima district topped the table with a percentage of 57% followed by Mokokchung and Peren districts at 54% and 52% respectively. Kiphire district is at the bottom with 7%.

In respect of private schools, Kohima district is at the top with a percentage of 88% followed by Zunheboto at 84%.

The number of candidates who secured 80% and above in aggregate is 1527, out of which, 20 candidates are from government schools.

#### B. HSSLC Examination 2022:

16 institutions under Arts stream, 10 institution under Science stream and 4 institutions under Commerce stream secured 100% pass result.

#### The performance of boys and girls streamwise in terms of pass percentage is:

The proper method like pit size, spacing, manuring, and mulching were taught to the farmers and the benefits of Trichoderma such as how it acts as a biofertilizer and an effective biocontrol agent in controlling or suppressing the pathogenic micro-organism and controlling root rot disease, damping off, wilt, fruit rot, etc. were explained to the farmers.

The farmers were distributed with King Chilli seedlings and Trichoderma viridie.

#### KOHIMA:

ATMA Kohima organized a farmers training-cum-exposure visit to Dimapur and Chumukedima district from 27<sup>th</sup> to 28<sup>th</sup> May 2022. Judge of Gauhati High Court, Kohima Bench, Justice Songkhupchung Serto and Judge of Gauhati High Court, Kohima Bench, Justice Kakheto Sema laid the foundation stone of District Court Complex, Noklak on 28<sup>th</sup> May 2022 at Nyungkeng, Nokyan B.

Justice Songkhupchung Serto in his address stated that for a society to stay happy and progress, it needs peace. He elaborated that, there are many ways to maintain and achieve dignified living in a society where peace is paramount. He stated that our customary laws are good and it is one of the sources of law, but due to custom and cultural changes, consequently, some customary laws may not be applicable with the changing of time, therefore, we need to adapt to the changes.

Justice Kakheto Sema said that the foundation stone laying is the first step for establishing the judiciary and with that Noklak has entered the judicial map of Nagaland. Justice Kakheto urged the people of Noklak to give full cooperation for the successful completion of construction and to establish a judicial court in the District. As long as Article 371 A of the Indian Constitution exists, customary laws will continue which are used by the Village Councils, GBs, DBs, and elders of the villages and towns. However, he said there are cases where customary laws are limited and require the intervention of the judiciary.

Deputy Commissioner, Noklak, Hiazu Meru, while appreciating the Judges of Gauhati High Court for laying the foundation stone for establishing the District Court Complex at Noklak, stated that with the beginning of the process of establishing a judicial court the District will be benefitted in many ways.
