In compliance to the Hon’ble Gauhati High Court, Kohima Bench Order dated 30.07.2024 passed in WP (C)/ 123/2024 and Judgment & Order dated 31.05.2023 passed in No. W.P (C) No. 122/2019 and in pursuance to the Government of Nagaland, Department of Health & Family Welfare letter No.HFW(A)COURT-4/122/2019/146 Dated Kohima the 30<sup>th</sup> Oct 2023. Applications from indigenous inhabitants of Tuensang District are hereby invited to fill up 1 (one) post of Grade-1V (Medical Attendant) as shown below under the establishment of the Chief Medical Officer, Tuensang.

- (1) The applicant should be an indigenous inhabitant of the concerned area. (As per Govt O.M. issued vide No.AR-3/GEN-174/2007 (PT) dated 26<sup>th</sup> October 2017)
- (2) The age of the candidate should not be less than 18 years and not more than 35 years as on 31.03.2024, which shall be supported by the Birth Certificate from the Department of Economics & Statistics.
- (3) Candidate should be at least Class V passed.
- (4) Application should reach to Chief Medical Officer, Tuensang on or before 16.08.2024.  
Interview will be held in the Directorate of Health & Family Welfare on 28.08.2024 starting from 12:00 Noon.
- (5) The candidates are hereby directed to bring the following documents in original.
  - (a) N.O.C from the respective Village Council/Ward Chairman.
  - (b) Indigenous Inhabitant Certificate.
  - (c) Schedule Tribe Certificate.
  - (d) Academic Documents.
  - (e) Birth Certificate
  - (f) Incomplete applications shall be summarily rejected by the Board.
- (6) Preferential treatment may be given to Land Ownership as per Court’s Order.
- (7) No separate calling letters will be issued, the selected candidates result will be notified in the local dailies.
