- Upon receiving expressions of interest, the CMMFI Facilitation Teams at both the district and state levels will coordinate with vendors to procure quotations tailored to the specific needs of individual beneficiaries.
- Once the quotations are incorporated into the Detailed Project Report (DPR) of the beneficiary's loan application, and upon approval, the respective bank will transfer the approved amount directly to the vendor's account.
- Loan applications and approvals will be facilitated through the State Credit Portal for a seamless and efficient process.

2. **Tentative Discount** offered to CMMFI beneficiaries.

Who Can Register?

1. **Shopkeepers and entrepreneurs** with or without **Udyam Registration**.
2. Members of **District and State-level business associations**.
3. Employees of the shops/business and enterprises: register yourself as breadwinners.
4. Enrol your family members as depends for accidental insurance coverage.

Special Features for Non-Udyam Registered Entrepreneurs:

- Entrepreneurs/shop keepers without Udyam Registration can avail **free Udyam Registration facilitation** through the **Swavalamban Connect Kendras (SCKs)** in their respective district headquarters.

Registration Process:

1. **Business Associations:** Register your members and their families on a **priority basis** to avail the scheme's benefits. Share the details in bulk to your nearest SCK.
2. **Individual Entrepreneurs:** Visit the nearest **SCK in your district headquarters** for assistance and enrolment in CMLIS.
3. Employees of the shops/business and enterprises: register yourself as breadwinner and at the time of registration produce the name of the establishment where you are working.
