This is in compliance of the Hon’ble Gauhati High Court, Kohima Bench Judgment Order dated 26.11.2024 passed in W.P (C) No. 160/2024, Shri. Pelingrang Hegui & 4ORS Vs- State of N/L & 2ORS.This order supersedes the previous order advertised vide No. DHFW-3/Court-case/Peren/Gr-IV/7519-26/dated 07.08.2024.

(1) The applicant should be an indigenous inhabitant of the concerned area. (As per Govt O.M. issued vide No.AR-3/GEN-174/2007 (PT) Dt. Kma, the 4<sup>th</sup> June 2016)

(2) The age of the candidates should not be less than 18 years and not more than 37 years as on 31.03.2025, which shall be supported by the Birth Certificate from the Department of Economics & Statistics.

(3) Candidate should be at least Class V passed.

(4) Application should reach the Directorate of Health & Family welfare, Nagaland Kohima on or before 21.03.2025, Room No-301(Establishment section) during office hour.

Interview will be conducted on 26.03.2025 from the Directorate of Health & Family Welfare Nagaland, Kohima (IDSP Hall) starting from 11.00 AM.

No separate calling letters will be issued, the selected candidates result will be notified in the local dailies.

**(5) Those applicants who have already applied against the above mentioned posts advertised vide Order No. DHFW-3/ Court-Case/Peren/Gr-IV/7519-26/dated 07.08.2024 need not re-apply.**
