In continuation to this Office Advertisement issued vide PHQ (B-1)1/Recruitment/Constables/2023/1687 Dated 30<sup>th</sup> Sept' 2025, Addendum dated 6<sup>th</sup> Nov' 2025 & 21<sup>st</sup> Nov' 2025, and press Notice dated 10<sup>th</sup> Dec' 2025, all candidates who have been provisionally accepted for Physical/Medical Standards Tests (PST) scheduled from **07/01/2026 to 13/01/2026**, are hereby informed and reminded through this press notice that they must compulsorily produce photocopies of the mandatory documents listed in the Advertisement, at their respective District Recruitment Rally venues for verification.

**MANDATORY DOCUMENTS TO BE PRODUCED AT THE VENUE**

1. **Proof of Educational Qualification:** Class-6 Passed Certificate or higher for Backward Tribes, and Class-8 Passed Certificate or higher for other Indigenous Naga Tribes of Nagaland from NBSE or any recognised Board of School Education in India.
2. **Proof of Identity:** Aadhar Card/ PAN Card/ Driving License.
3. **Certificate of Indigenous Inhabitant of Nagaland.**
4. **Scheduled Tribe Certificate and Backward Tribe Certificate** (as applicable), duly signed only by the District Authority not below the rank of Additional Deputy Commissioner.
5. **Proof of Date of Birth:** Birth Certificate/ Matriculation or equivalent Admit Card.

Applicants who could not successfully uploaded **Backward Tribe Certificate** must mandatorily produce photocopy of the same at the Recruitment Rally venues for verification. They may download Admit Card generated in the portal.

Candidates who fail to produce any of the above mandatory documents at the time of the Physical/Medical Standards Tests shall be liable for rejection of candidature as per the terms and conditions of the Advertisement.

Further, in view of the large number of candidates, scrutiny of documents will commence from **2<sup>nd</sup> of January 2026 onwards at all venues**. Accordingly, candidates who have successfully generated their Admit Cards in the Nagaland Police Recruitment Portal are hereby informed to report (**Reporting Time 05:30 A.M.**) at their respective District Recruitment Rally venues from the aforesaid date for documents scrutiny.

This Notice shall be treated as information to all concerned candidates, and no further separate individual intimation will be issued in this regard.
