NOTIFICATION ON NEW HOSTEL REGISTRATION FOR POST MATRIC STUDENTS

It is hereby notified for general information that the Directorate of Higher Education (Scholarship Section) will issue application forms for **New Hostel Registration** for Post-Matric Students from **6th – 30th April 2026**. The last date for submission of duly filled application forms is **8th May 2026**. No applications shall be entertained after the stipulated deadline. Individuals/organizations intending to run hostels for Post-Matric students may collect the prescribed application forms from the office of the undersigned within the specified period.

Further, all hostels already registered under this Directorate and due for renewal must submit the Hostel Eligibility Certificate for renewal process within the prescribed time. Failure to comply shall result in automatic cancellation of the hostel registration, and such hostels shall be treated as null and void without further notice.

It is also hereby clarified that the **Hostel Eligibility Certificate** is issued strictly for the purpose of facilitating scholarship benefits to Post-Matric students residing in eligible hostels, in accordance with the prevailing scholarship guidelines. Any misuse or misrepresentation in connection with the Hostel Eligibility Certificate shall invite strict action as per applicable rules, and the concerned individual/authority shall be held solely responsible.
